## How can higher education become more gender equal?

KMOP Education & Innovation Hub, in cooperation with the University of Macerata, organised the Online International Workshop, titled “How Can Higher Education Become More Gender Equal?” on November 5th 2024. This discussion brought together experts, academics, and civil society representatives from across the EU, by offering a platform to explore how higher education institutions can play a leading role in advancing **gender equality, diversity, and inclusion**. Through interactive dialogue and real-life examples, speakers shared practical approaches to institutional transformation, inclusive policy-making, and the implementation of long-term change.

A highlight of the event was the presentation of Google Slides Book and the **Handbook on Implementing Gender Equality Plans in Higher Education Institutions**, a set of valuable resources developed under the PRO-GENDERING project.

The Pro-Gendering team has finalised the *Handbook on Implementing Gender Equality Plans in Higher Education Institutions* — a practical guide for universities aiming to design and implement effective Gender Equality Plans aligned with national priorities and EU-level commitments.

The handbook provides clear guidance on monitoring and evaluation tools, highlights best practices in inclusive teaching and safe learning environments, and outlines effective policies to prevent gender-based violence. It also showcases real-life community-building initiatives that promote meaningful gender equality within academic institutions.
